BEWARE OF BILLING IVERMECTIN FOR OFF-LABEL USE

Beware of billing ivermectin to third party payers for Covid. We have heard of PBMs auditing and taking payment back because it is "clinically inappropriate." Medicare and other federal programs do not pay for off-label use. Here is a link from the FDA:

Why You Should Not Use Ivermectin to Treat or Prevent COVID-19

COVID-19. We've been living with it for what sometimes seems like forever. Given the number of deaths that have occurred from the disease, it's perhaps not surprising that some consumers are looking at unconventional treatments, not approved or authorized by the Food and Drug Administration (FDA).

Though this is understandable, please beware. The FDA's job is to carefully evaluate the scientific data on a drug to be sure that it is both safe and effective for a particular use, and then to decide whether or not to approve it. Using any treatment for COVID-19 that's not approved or authorized by the FDA, unless part of a clinical trial, can cause serious harm.

There seems to be a growing interest in a drug called ivermectin to treat humans with COVID-19. Ivermectin is often used in the U.S. to treat or prevent parasites in animals. The FDA has received multiple reports of patients who have required medical support and been hospitalized after self-medicating with ivermectin intended for horses.

Here's What You Need to Know about Ivermectin

- FDA has not approved ivermectin for use in treating or preventing COVID-19 in humans. Ivermectin tablets are approved at very specific doses for some parasitic worms, and there are topical (on the skin) formulations for head lice and skin conditions like rosacea. Ivermectin is not an anti-viral (a drug for treating viruses).
- Taking large doses of this drug is dangerous and can cause serious harm.
- If you have a prescription for ivermectin for an FDA-approved use, get it from a legitimate source and take it exactly as prescribed.
- Never use medications intended for animals on yourself. Ivermectin preparations for animals are very different from those approved for humans.

What is Ivermectin and How is it Used?

Ivermectin tablets are approved by the FDA to treat people with intestinal strongyloidiasis and onchocerciasis, two conditions caused by parasitic worms. In addition, some topical (on the skin) forms of ivermectin are approved to treat external parasites like head lice and for skin conditions such as rosacea.

Some forms of ivermectin are used in animals to prevent heartworm disease and certain internal and external parasites. It's important to note that these products are different from the ones for people, and safe when used as prescribed for animals, only.

When Can Taking Ivermectin Be Unsafe?

The FDA has not reviewed data to support use of ivermectin in COVID-19 patients to treat or to prevent COVID-19; however, some initial research is underway. Taking a drug for an unapproved use can be very dangerous. This is true of ivermectin, too.

There's a lot of misinformation around, and you may have heard that it's okay to take large doses of ivermectin. That is wrong.

Even the levels of ivermectin for approved uses can interact with other medications, like blood-thinners. You can also overdose on ivermectin, which can cause nausea, vomiting, diarrhea, hypotension (low blood pressure), allergic reactions (itching and hives), dizziness, ataxia (problems with balance), seizures, coma and even death.

Ivermectin Products for Animals Are Different from Ivermectin Products for People

For one thing, animal drugs are often highly concentrated because they are used for large animals like horses and cows, which can weigh a lot more than we do—a ton or more. Such high doses can be highly toxic in humans.

Moreover, FDA reviews drugs not just for safety and effectiveness of the active ingredients, but also

for the inactive ingredients. Many inactive ingredients found in animal products aren't evaluated for use in people. Or they are included in much greater quantity than those used in people. In some cases, we don't know how those inactive ingredients will affect how ivermectin is absorbed in the human body.

Meanwhile, effective ways to limit the spread of COVID-19 continue to be to wear your mask, stay at least 6 feet from others who don't live with you, wash hands frequently, and avoid crowds.

COVID-19 Booster Dose Guidance

Please see below for updated booster dose guidance:

- Administration of the product off label may not be covered under the PREP Act or the PREP Act declaration; therefore, providers may not have immunity from claims.
- Individuals who receive an off-label dose may not be eligible for compensation under the Countermeasures Injury Compensation Program after a possible adverse event.
- CDC has defined the scope of the CDC COVID-19 Vaccination Program in terms of how the USG-provided vaccines may be used in the program. Providers giving off-label doses would be in violation of the CDC Program provider agreement potentially impacting their ability to remain a provider in the CDC program.
- Administration fees may not be reimbursable by payers.

PBMs: 21st century robber barons

Jeff Bezos, founder of Amazon and the richest man on the planet, was in the news for a couple of reasons this summer. One, for taking a sub-orbital space jaunt, and two, for his comments that some viewed as interstellar tone deafness: "I want to thank every Amazon employee and every Amazon customer, because you guys paid for all of this," said Bezos, whose net worth is approximately \$214 billion.

I'm far from a history buff, but I like the History Channel series about the individuals who built America. Bezos' comments reminded me of a recent History Channel podcast and the National Community Pharmacists Association's outreach to the Federal Trade Commission.

"Robber barons" was a not-so-flattering term used to describe industrialists in the late 19th and early 20th century who helped inspire the need for the Sherman Antitrust Act. As a quick refresher, the Sherman Act was created to promote economic fairness and competition. It passed 51-1 in the Senate (the only vote against was by Sen. Rufus Blodgett, a one-term senator from New Jersey who was superintendent of the railroads for 25 years) and 242-0 in the House.

"Robber baron" was a pejorative term directed at monopolists who engaged in unethical business practices, exploited their workers, and cared little about their customers or competition. Names from that era that are often mentioned in the same breath with robber baron include John Rockefeller, Cornelius Vanderbilt, and J.P. Morgan.

The FTC was created in 1914, not coincidentally as the U.S. was trying to rein in robber baron behavior and protect consumers from their one-sided practices. Community pharmacy has its own version of robber barons called pharmacy benefit managers. PBMs produce some of the same anti-consumer, anti-small business, anti-competition results as the robber barons from more than a century ago. For many years, the FTC has allowed PBMs to grow bigger and exert their market leverage to the benefit of shareholders and at the expense of small businesses and consumers. But lately there have been some signs of changing attitudes.

The Biden and Trump administrations are very different, but so-called "Big Tech" companies like Facebook, Amazon, and Google have drawn the attention of both. In July, President Biden signed an executive order directing federal regulators to look into the impact of corporate consolidations that have resulted in oligopolies in several industries, including PBMs in health

NCPA has been a constant voice at the FTC for decades, flagging our concerns with the one-sided, take-it-or-leave-it PBM contracts, patient steering, and the problems with PBMowned and -affiliated pharmacies that decide the reimbursement of their competitors. Lina Khan, a vocal critic of Big Tech, has been named FTC Chair. NCPA congratulated Khan on her appointment. Additionally, NCPA General Counsel Matt Seiler was able to get a slot to present to the FTC commissioners in their first public forum and we also have spoken with White House advisers about the need for anti-trust oversight.

There is momentum here for probes into what we contend is anti-competitive behavior. Change won't come easy or fast. The FTC provides guidance but it's Congress that makes laws and it's courts that referee those laws. There are 40 years of legal precedence in which courts have supported practices that have led to the current situation. It will take some time to evolve to a pro-consumer state. But the recent actions are encouraging.

High trust in doctors, nurses in US, AP-NORC poll finds

WASHINGTON (AP) — Most Americans have high trust in doctors, nurses and pharmacists, a new poll finds.

Researchers say that trust could become important in the push to increase COVID-19 vaccinations, as long as unvaccinated people have care providers they know and are open to hearing new information about the vaccines.

At least 7 in 10 Americans trust doctors, nurses and pharmacists to do what's right for them and their families either most or all of the time, according to the poll from the University of Chicago Harris School of Public Policy and The Associated Press-NORC Center for Public Affairs Research.

The poll shows high levels of trust among both Democrats and Republicans; men and women; and white, Black and Hispanic Americans

When people get treatment or a service from a doctor or a nurse, they start building trust and then tend to return to those providers when they need more help or have questions about a health issue, said Michelle Strollo, a senior vice president in NORC's Health Research Group.

"Public health officials should really look to doctors, nurses and pharmacists to be the megaphone to deliver the message of the importance of getting vaccinated," she said.

Polling from the nonprofit Kaiser Family Foundation in <u>June</u> also showed people trusted doctors for information about the vaccine more than other sources like the Centers for Disease Control and Prevention and Dr. Anthony Fauci, the U.S. government's top infectious disease expert.

COVID-19 case levels are soaring across the country, driven by a highly contagious <u>virus variant</u> that mostly infects unvaccinated people, according to public health experts. President Joe Biden and others have pleaded with Americans to get the shots.

The COVID-19 vaccines have been widely available since spring, and the CDC reports that 71% of U.S. adults have received at least one dose.

Recently retired cardiologist Paul Vaitkus said he encouraged many of his patients, some of whom have been seeing him for years, to get the vaccine due to their health conditions. He thinks they listened to him.

"As a doctor, my patient knows me and they sized me up eye to eye," the 62-year-old Gurnee, Illinois, resident said. "They know that I'm honest."

Care providers could help encourage people to get vaccines, but the country's fragmented health care system presents an obstacle.

Vaccination rates are low among the uninsured, noted Liz Hamel, director of public opinion and survey research for Kaiser.

"Those are the same people who are less likely to be in regular health care, to have those interactions with doctors and providers," she said.

The same holds true for younger adults, who also have low vaccination rates. They are less likely to see a doctor regularly or get preventive care like annual checkups.

Plus, just getting someone into a doctor's office or drugstore offers no guarantee that the patient will become vaccinated.

Hamel noted that attitudes toward the shots have become so politicized that people who trust a doctor to give them advice about other issues may not be open to hearing more about the vaccines.

"I think some people, based on politics, have completely closed off," she said.

Doctors earn broad trust from the American public, and a slim majority are in favor of federal funding for increasing the number of doctors, according to the AP-NORC poll. But only about 2 in 10 support government funds for increasing doctors' pay. Half of Americans say doctors are paid about right.

However, most Americans, including majorities of both Democrats and Republicans, think nurses and health care aides are underpaid.

Even as the COVID-19 pandemic continues to plague the U.S., the poll finds no significant shifts in opinions about health care policies, including the Affordable Care Act, a single payer health system or a public option.

The AP-NORC poll of 1,071 adults was conducted from June 10 to June 14. It used a sample drawn from NORC's probability-based AmeriSpeak Panel, which is designed to be representative of the U.S. population. The margin of sampling error for all respondents is plus or minus 4.2 percentage points.


